I, the undersigned, hereby acknowledge that I have voluntarily chosen rent all terrain vehicles from NEVADA RECREATION. I know and fully understand that all terrain vehicle riding, an outdoor activity is a dangerous and hazardous activity where serious accidents can occur and participants can die or sustain serious personal injuries, and/or property damage. I understand and acknowledge that all terrain vehicle riding, involves numerous hazards, exposures, and risks that can result in illness, personal injury, death, and property damage, including but not limited to, riding on different and carious courses, trails, roads, or untracked wilderness areas, riding on rough and uneven terrain, changing conditions, and variations in elevations; loss of control of the all terrain vehicle, falls from the all terrain vehicle, collision with other ATVÕs, participants, trees, rocks, and other man-made or natural obstacles, whether they are obvious or not obvious; exposure to the elements for extreme temperatures, inclement weather, encounters with animals and wildlife; and any mechanical and/or equipment problems, and accident or illness in the outdoors without medical facilities, physicians, or nurses.

I further acknowledge, willingly and voluntarily agree that the terms of this release shall serve as a complete and full release and discharge of any an all legal liability for negligence or any other acts as to Nevada Recreation , all other parties and affiliates named herein, and as an assumption of risk for myself ( or any minor's whose behalf I am signing this release) and my personal representatives, heirs, next of kin, spouse, members of my family and assigns.
